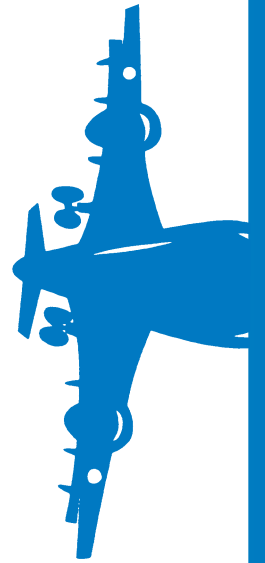
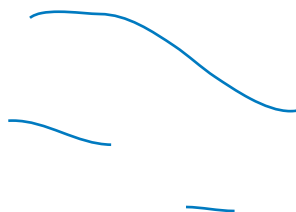

2005 IPAA LEGISLATIVE PRIORITIES SET

AirWaves

The start of the 2005 Iowa Legislative Session is less than four months away, and the IPAA Board of Directors is already planning a proactive agenda for the association at the Statehouse.

Following a series of meetings, the Board of Directors has developed an aggressive four point legislative plan that will provide the needed funding for the state's aviation system. The plan also seeks to give airports a needed tool to get aviation dependent businesses to locate on airport grounds.

Here are the IPAA's 2005 Iowa Legislative Priorities:

#1 The creation of a dedicated fund for support of aviation in the state.

The IPAA is urging lawmakers to designate at least \$3 million a year for aviation projects and programs through the establishment of the new Aviation an Iowa Resource or AIR fund. The AIR fund would be funded through the anticipated increase in gaming revenues resulting from the expansion of gambling in the state.

#2 The continuation of Rebuild Iowa Infrastructure Fund appropriations for vertical infrastructure projects at both commercial and general aviation airports.

#3 The creation of Airport Development Zones. Many public airports in this state are not located within the corporate boundaries of a city. As a result, these locations

do not have the ability to attract aviation dependent businesses such as air freight. The creation of Airport Development Zones would allow an airport governing body or aviation authority the ability to create a tax increment financing district on the grounds controlled by an airport.

#4 Monitor any and all other legislative actions or initiatives that may affect the IPAA and its members.
